- I. Call to Order: President Joy Salcedo called the meeting to order at 3:30 pm.
- II. Amazon Business Account Katrina McDowell made a motion to create an Amazon Business Account and put the President, President-Elect and Treasurer on the account to carry out transactions as needed. Jeanne Tholen seconded the motion. Motion passed.
- III. BMITE Official Logo Derick Jones is working on a new logo and is waiting for confirmation for OKACTE if their colors and likeness should be used.
- IV. Division T-shirts for paid members for Summit Joy asked for discussion on the idea of all paid members receiving a T-shirt at Summit with the new logo on it. Meredith Walker asked if OKACTE might be able to add a t-shirt size to the registration form for BMITE to simplify the process of collecting t-shirt sizes. Joy said she would check on that. Mark Burch suggested it may be good to have the members register by a certain date in order to get the t-shirt. Joy said the BMITE officers could possibly have a booth to hand those out at Summit. Several Stillwater T-shirt vendors were discussed including EJPPG, Dupree's, and Stillwater Screen Printing as options for design/printing of the T-shirts.

Discussion was held over donating some of the budget to help pay for speakers at Summit. Daniel Devers added in order to do that, a motion to allocate funds and add it to the budget will need to take place.
